By publicly posting this written disclosure, the District of Columbia (“District”) intends that market participants receive and use it for the purposes of the independent registered municipal advisor exemption in accordance with the SEC’s municipal advisor rules provided by 17 CFR §240.15Ba1-1(d)(3)(vi).

The District is open to receiving financial proposals and related materials from interested persons. In this connection, the District has engaged the financial advisors identified below (“Financial Advisors”) to serve as its independent registered municipal advisors. Accordingly, any financial proposals and related materials regarding an issuance of municipal securities that are provided to the District for its consideration will be forwarded by the District to the appropriate Financial Advisor(s). The District is represented by its Financial Advisors, and the District will rely on the Financial Advisors’ advice (in the sense that it will seek and consider the advice, analysis and perspective of the Financial Advisors) in considering any financial proposals or related materials regarding an issuance of municipal securities that are submitted for its consideration.
