Application Requirements

All applicants for an Inauguration Vending License must comply with the following DC Code requirements:

Vending Business License Application

All applicants for an Inauguration Vending License must complete an application, remit the associated payment, and submit the required supporting documentation.

Clean Hands Self-Certification

All applicants must certify that no more than \$100 is owed to the District of Columbia Government as a result of fees, penalties, interest, or taxes through completion of a *Clean Hands Self-Certification*.

Tax Number

All Applicants must provide a registered tax number (i.e., SSN or FEIN) at the time of application. Register by completing and filing a *Combined Business Tax Registration Application (Form FR-500)* with the Office of Tax and Revenue, 1101 4th Street S.W., Suite W270, Washington, DC 20024. Online registration is available at the Business Tax Service Center (otr.cfo.dc.gov). For more information, please call the Tax Customer Service Center at (202) 727-4829.

Propane Operation Permit (*If applicable*)

All applicants for a Basic Business License for the Mobile Delicatessen category must provide an approved inspection from the DC Fire Marshall pursuant to DC Municipal Regulations and the DC Code. All businesses that manufacture, wholesale, warehouse, distribute, sell or use toxic or flammable materials or provide services to large audiences (theatres, restaurants, and public halls) are subject to inspection to ensure the safety of customers, employees, and property. A Fire Marshall Inspection can be obtained from the DC Fire and Emergency Medical Services (FEMS) Department, Fire Prevention Inspection Division (fems.dc.gov), (202) 727-1614, 1100 4th Street S.W., Washington, DC 20024.

Health Inspection Report Approval

All applicants for an Inauguration Vending License must be inspected by and/or receive approval to operate from the Department of Health, Food Protection Division, (doh.dc.gov), (202) 535-2180, 899 North Capitol Street N.E., Washington, DC 20002.

Certified Food Supervisor

Delicatessens must have Certified Food Supervisor(s) present on the premises during the hours the facility is open to the public. The name(s) and certification(s) of the food supervisor employee(s) must

be provided to Department of Health inspectors. For more information, please contact the Office of Certification, Health Regulation and Licensing Administration, (doh.dc.gov), (202) 535-2180, 899 North Capitol Street N.E., Washington, DC 20002.

Police Criminal History Report (Form PD-70)

All applicants for an Inauguration Vending License must provide a certified copy of his/her Police Criminal History Report from the jurisdiction of residence. A resident of the District of Columbia may obtain a Police Criminal History Report (PD-70) from the DC Metropolitan Police Department, Police Criminal History Report Division, 300 Indiana Avenue N.W., Room 3055, Washington, DC 20001. Call (202) 727-4245 for details. A non-resident shall obtain this report from the jurisdiction in which he/she resides. All of the partners in a partnership, and the president, vice president, secretary, and treasurer of a corporation must provide a Police Criminal History Report.

Application Submission Methods

In-Person

You may apply for a Inauguration Vending License in-person with cash, check, money order or a major credit/debit card by visiting the Department of Consumer and Regulatory Affairs, Business Licensing Center, 1100 4th Street S.W., 2nd Floor, Washington, DC 20024. No appointments are required. Applications are processed on a first-come, first-served basis. **Note: American Express is not accepted in the Business Licensing Center.**

Via Mail

You may apply for an Inauguration Vending License and pay with a check or money order via mail. Please submit all requirements including the associated fee. Note the late fee schedule, if envelopes are postmarked after the deadline dates, please ensure the payment reflects late fees. Make check or money order payable to “D.C. Treasurer.”
